	<p>Alberta NDP: No official statement regarding the sanctity, meaning or purpose of life. No official statement regarding human engineering, including cloning and cell manipulation, or gender election surgery. Related policies include preventing harassment at abortion clinics and expanding access to abortion.</p>
	<p>Prolife Alberta: statement regarding <i>Sanctity of Life</i>: commitment to promoting pro-life public policy in Alberta. All human life deserves protection, especially innocent human life. No official statement on human engineering. Related policies include boosting support, including counselling, for women experiencing unwanted pregnancies; easing the challenges of adoption; requiring that women contemplating abortion be provided with all the information to provide informed consent; ensuring that parents of minors are informed of minors’ decision to undergo abortion procedures, and eliminating taxpayer funding.</p>
	<p>United Conservatives <i>Sanctity and Purpose of Life: A full life includes work that provides not only a living, but dignity. The first priority is to boost the economy and bring quality jobs back to Alberta. While the government can’t guarantee a good life, it has a central role in establishing many of its conditions, such as health, safety, education, and support for the vulnerable.</i> No official statement on abortion or alternatives, or human engineering. Related policies include education about and access to palliative care.</p>

Rethinking sustainable practices, making strategic investments in research and technology and implementing smart policy choices will protect and enhance our environment. Related policies include encouraging the shift towards a decarbonized energy system, employing a carbon-levy, working with other governments for access to oil and gas via pipelines, supporting the development of micro-generation, renewing the Water for Life strategy, and supporting the implementation of the Land Use Framework. .</p>
	<p>Green Party of Alberta <i>The six principles of the Global Green movement include commitment to ecological wisdom and sustainability. Human beings are part of the natural world. Respect the specific value of all forms of life. Recognizes the limited</i></p>

Environmental protection must be a synergistic process with consumer and industry buy-in.</i> Related policies include removal and prevention of soil and water contaminants, improving water management, reviewing and improving project requirements, wildlife conservation, development of new gas and coal technologies, review of mineralogical data and mining resources, holistic “Alberta First” agricultural techniques, sustainable logging practices, development of a new fur industry.</p>

Alberta Party has expressed a commitment to defending the rights of all Albertans, but has not outlined any policies supporting that commitment.

Green Party of Alberta Related policies include enforcement of the legal right to food, increasing food security by supporting small and medium-sized agroecological mixed farms, amending the school curriculum to ensure that every child can grow food to feed themselves and understand the global food system, advocating for the robust legal protection for the human rights of all Albertans through ensuring the Human Rights Commission functions effectively, amending the Alberta Human Rights Act to eliminate names, gender, and age from hiring and application processes, to make it illegal to discriminate in employment on the basis of a conviction unrelated to the employment or intended employment of the applicant, and to make it illegal to ask for a record check until a job offer has been made/make it illegal to withdraw the job offer should a criminal record exist (unless it is related to the intended employment of the candidate), mandating that all government departments and

	<p>agencies include the “other” option wherever gender is to be specified in forms or procedures.</p> <p>The Independence Party. Related policies pertain mostly to responsible gun ownership, including reform of existing firearms legislation, harsher penalties for the possession of illegal firearms, penalties for violent and organized criminal activities, free and mandatory mental health screening for license renewals, educating licenses on mental illness complications, ensuring that Albertans suffering from mental illnesses receive the care they need, striving to reduce license processing times for new licenses and renewals (one month cap), ensuring that Albertans who use firearms defensively are not punished unfairly.</p> <p>Alberta Liberal. Related policies include implementation of Pay Equity Legislation, boosting funding for women’s shelters in Alberta, enacting budgets that focus on examining/assessing impacts on women and minorities, introduction of free birth control for women, ensuring support for female politicians and their childcare responsibilities, mandating appropriate training for police officers and judges pertaining to sexual assault, harassment and consent, exploring portable housing for women fleeing domestic violence, providing universal subsidized child care, making sure women have full access to abortion including in rural communities, funding one cycle of in-vitro fertilization, funding of medical procedures for transgender Albertans, elimination of gate-keeping and fully funding hormone treatments for trans women, modernization of the Alberta Human Rights Act and expanding grounds of discrimination (pregnancy, social condition, Indigenous heritage, political belief, language, addiction, HIV-positive status, physical size or weight), requiring all health facilities to provide MAID services on site, fighting against racism and hate groups, updating the Alberta Curriculum with age-appropriate content about the history of LGBTQ2S+ populations in Canada and the world, supporting mandatory GSAs in all schools where they are requested, opposing the requirement to inform parents when their kids join a GSA without their consent, banning conversion therapy in Alberta,</p> <p>Alberta NDP. Related policies include reforming government hiring practices to eliminate bias, creation of a Ministry of Multiculturalism to educate and promote diversity, inclusion, and mutual respect, working with communities that have experienced hate crimes at their places of worship to increase security and restore a sense of safety, reviewing and modernizing grants to community groups and non-profit organizations to allow more organizations to be eligible.</p> <p>United Conservatives. Related policies include acknowledging the genocide and recognizing the sovereignty of Indigenous Peoples of Canada, ensuring that the commitment to sovereignty will permeate all policy development, lawmaking and day to day operations (including the provincial government abiding by the letters and spirit of the constitutional duty to consult and accommodate Indigenous peoples), negotiation of revenue sharing agreements with indigenous communities affected by resource developments, enforcing compliance pertaining to licenses and permits issued by governments, making loans and advances against shared revenue available to indigenous communities, mandating that all government properties where provincial or national flags are flown also fly the applicable Treaty flag or flag of the local first nation(s) on equal footing, ensuring that local First Nations elders are properly engaged prior to the first raising of such flags, acknowledge a provincial obligation to the <i>United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP)</i>, reviewing existing Alberta laws to identify those non-compliant with the Declaration and amending or revoking those laws, endorsing the report of the TRC and the 94 calls to action, taking proactive steps to determine whether systemic abuses against indigenous peoples are also occurring in Alberta, recognition of traditional indigenous hunting rights, establishing a commission to review the qualifications of foreign trained and out of province professionals to certify applicants to practice in Alberta.</p> <p>The Independence Party.
